COVID-19 VACCINATION BOOSTER: HOW TO SCHEDULE

Governor Hochul encourages New Yorkers who are 18 and older and feel at risk to get their COVID-19 booster dose. This includes individuals who received their Pfizer-BioNTech or Moderna initial vaccine series at least six months ago or the Janssen/Johnson & Johnson COVID-19 vaccine at least two months ago. New Yorkers may feel at increased risk of COVID-19 because of their occupational or institutional setting — meaning where they work or live. Individuals who have questions about their risk are encouraged to consult with their primary health care providers.

INDEPENDENT LIVING THROUGH SELF-DIRECTION

In late October, representatives from Advocates' residential team presented "Independent Living Through Self-Direction: Putting the Pieces Together" at the 2021 Cerebral Palsy of NYS Annual Conference. This statewide conference presented an array of sessions to help us collectively navigate forward in positive and exciting ways by becoming better practitioners, caregivers, and advocates.

Advocates' presentation focused on Self-Direction and the many approaches used to design supports that are best for an individual to help reach his or her unique independent living goals. Topics included getting started with the Self-Direction process and how to leverage a person's budget to support non-certified independent living. Discussions also focused on self-hired staffing, Residential Coordination, Paid Neighbor and Live-in Caregiver components, and multiple ways to put the pieces together based on Residential Person-Centered Planning through Housing Navigation.

By connecting with another loved one in his circle of support, this morning ritual helps set the tone for Chase's day.

MEET LESLIE PERKINS

Finding a Voice

Leslie Perkins has a lot to say these days. Her loved ones and those with whom she works say she is content and loving life. Sadly, this hasn't always been the case for her.

Leslie, 54, has received services from Advocates for four years. Prior to this, she participated in a certified day program, where many of her daily activities were predetermined for her. She mostly kept to herself and felt she couldn't express her desires,

needs, or goals. Those closest to Leslie say that a lot of this changed when she joined Advocates, and her demeanor has followed suit. "Her communication and socialization skills have grown tremendously since we started working together," said Kristin Smith, who has acted as Leslie's Mentor since Leslie first began receiving services through Advocates. "When we first met, she couldn't verbalize her wants, and this was a barrier." This barrier would quickly be overcome, as Leslie and Kristin formed an instant bond.

Almost immediately upon working together, Leslie began verbalizing more with Kristin. Leslie was able to express things like what she wanted for lunch or where she wanted to go that day. The rapport the pair had built gave Leslie the confidence to communicate with others in her community as well.

"I'm happy," Leslie told us while visiting one of her favorite spots in town – McDonald's. Though she loves their french fries, she enjoys the atmosphere and interacting with the restaurant's staff much more. It's a place where she feels safe and welcome, as the employees often stop over to her table to chat.

One real area of progress for Leslie is being able to communicate things that bring her happiness. She enjoys artwork, volunteering, bowling, meeting with friends, and visiting area lakes and parks. Exploring these and other interests gives Leslie satisfaction



because it is she who chooses to do them. It is her contentment that gives those closest to her a similar sense of satisfaction.

"Leslie's relationship with Kristin and Advocates in general has opened doors for her," said her brother, Robert. One of those doors is volunteer opportunities. Leslie generously lends her time to Iroquois Nursing Home in Jamesville. There, she helps with group activities and takes an active role in boosting the morale of the residents. By reading a book with them or even just

spending a few minutes together, Leslie's big heart and infectious smile brighten the day of everyone she encounters.

"I'm instantly in a good mood when I see her because she's always so happy," said Leslie's Community Habilitation Coordinator with Advocates, Sarah Cowles. "It's been a pleasure seeing her blossom and advocate more for herself these past four years." Through this self-advocacy and some regular motivation from Kristin, Leslie has shown signs of becoming more independent. With Kristin's support, Leslie takes pride in being able to now make her own lunch, tidy her room, hang clothing out to dry, and work on her culinary skills through a cooking group. "It's one of those situations where we've found soulmates," Sarah said, referring to Leslie and Kristin. "Seeing their relationship and how they're always smiling together makes me really appreciate my job."

Everyone has a multitude of things to convey, and everyone has the right for their voice to be heard. Leslie is a prime example that sometimes, all it takes is the right group of people and a little positive reinforcement to hear just how beautiful a person's voice truly is. The best part is that we're hearing more than just Leslie's voice these days...we're hearing how she wants to live her life.


MENTOR SPOTLIGHT: ELYSSA STALLCUP

Passionate. Diligent. Advocating.

Three words that Elyssa Stallcup says best describe her. Three words that also embody the spirit of mentorship.

Elyssa has been a Mentor with Advocates for more than four years but has been mentoring her twin brothers, both of whom are diagnosed with autism, for as long as she can remember. From an early age, she has played an integral role in their development, helping them with everyday tasks and learning new skills.

Unbeknownst to Elyssa, her personal experience was setting her up for future successes professionally. Her firsthand glimpse of life in the disability world has benefitted her in ways that go beyond a paycheck, however, "I got an enhanced world view because of my brothers, and they opened my eyes in a lot of

Soon after this encounter, Elyssa applied for a Mentor position with Advocates, and was quickly hired by a young woman named Hannah. With her evolving skill set, valuable on-the-job experience, and an ever-growing appreciation for work in the disability field, Elyssa aimed to take her career to new heights. She changed her major to linguistics, largely due to having helped Hannah with her goal of refining her skills in both Spanish and English. Working with Hannah in this way and seeing her progression led to Elyssa setting a new goal for herself – to become a teacher for those whose second language is English.

When asked about her accomplishments through her work, Elyssa was quick to show her humility. "I don't want to take credit for anything Hannah has achieved," she said. "I love seeing the results, but the strides she's taken are because of her determination, not anything I did."

By not seeking praise for her work, Elyssa shows why she is that much more deserving of it. Her earnest desire to provide the best support possible is most apparent – whether it's to the families she supports, others in the community, or members of Advocates' staff who have witnessed her person-centered approach. Brittany Jewell, Training and

Support Specialist Supervisor at Advocates, shared with us her recent observation of Elyssa's exemplary work at our Fayetteville community space.

"She (Elyssa) was asking (the person she supports) how he'd like her to support him differently the next time, or what he'd like to do more independently next time," Brittany said. "I thought this was great because it makes him aware of what his goals are. Observing them in person was a really great experience."
